### **Pay Policies & Practices - Johns Hopkins University**

A bonus payment that is communicated to an employee before the work is performed cannot be treated as a discretionary bonus under the Fair Labor Standards Act (FLSA). A forward thinking bonus must meet the policy provisions for Incentive Pay or Commission plans.

### **Reward and Recognition Plans: Policies: University**

First, an employer should determine whether they are drafting a discretionary or non-discretionary bonus plan. A bonus policy must fit one of these two categories, and the employer should clearly state which one it chooses. If discretionary, the policy can simply read, "Our Company may pay bonuses in its sole discretion depending on the ..."

### **DRAFTING BETTER BONUS POLICIES - Employment Matters**

There is a guaranteed annual bonus equivalent to a thirteenth payment of basic pay. Otherwise, bonuses are discretionary and depend on the performance of the individual and business unit in which they are employed; therefore, besides the thirteenth payment, no employee has a guaranteed bonus.
